PRODUCT DESCRIPTION

DeDust™ Dust Control agent is an agriculturally based and calcium chloride-free liquid concentrate.

RECOMMENDED USES

- Suitable for dusty driving surfaces
- Gravel, Dirt, Asphalt, Concrete
- Streets, Driveways, Farm roads, unpaved parking lots

APPLICATION

- Requires no special applicator.
- Add DeDust to the applicator tank.
- Mix in water at a rate of 1/2 oz. DeDust Per 5 gallons of water.
- Spray-apply DeDust through standard dust control applicator
- Spray-apply liberally, drenching the dusty/dirty surface with dilute solution
- Apply DeDust mixture once after every heavy rain event

CAUTION/LIMITATIONS

- Always pre-mix before applying.
- DeDust is designed to suppress dust, but will not eliminate dust completely
- Rain events may dilute the effect of DeDust.
- Recommended to re-apply DeDust dilution after every rain event to maintain dust suppression.
- Driving onto treated surface will disturb application effectiveness but may be difficult to avoid

SURFACE PREPARATION

No special surface preparation is required for DeDust application. Avoid applying DeDust immediately after heavy rain events if the dusty surface shows pooling.

SAFETY/HANDLING

- Personal Protective Equipment (PPE) such as goggles, gloves and impervious clothing are recommended.
- First Aid: Refer to the Safety Data Sheet for first aid measures. Avoid inhalation and ingestion. If exposed to skin, wash with soap and water. If exposed to eyes, flush eyes immediately.

STORAGE

Store in the manufacturer's sealed container. Store in a dry, temperature-controlled environment that is well-ventilated. Do not store outside. Do not expose to high heat or freezing temperatures. To use stored product, mix for at least 45 minutes at ambient indoor temperature before application.

DISPOSAL/CLEANING

- Reactivity with water: none
- Disposal methods: Dispose of this material by incineration or by a licensed waste disposal company. Contaminated absorbent material may be disposed of in an approved landfill. Follow all local, state and Federal disposal regulations.
- Avoid contact with strong alkalis and oxidizing agents.
- In Case of Spill: Floors may become slippery. Use protective equipment. Contain liquid spills using a barrier or absorb using inert material. Scoop or shovel absorbed material into containers. Wash area with soap and water.
- Cleaning: Use BioSpan BST Cleaner to thoroughly rinse the spray application system of any residual polymers or residue.
